1 RULES

The regatta is subject to the rules as defined in the "Racing Rules Sailing".

- The skipper must have either a valid DSV driving licence, a youngest sailing licence, a sports sailing licence or an official driving licence prescribed or recommended for the sailing area, also issued and valid by the DSV on behalf of the Federal Ministry of Transport, Building and Housing. In the case of members of other national associations, a corresponding certificate of competency from their country applies.
- Each team member must be a member of his national association. For members of a German association, registration on the DSV website is recommended.
- Jury hearings can be negotiated according to the Arbitration System.
- Please observe the general rules of conduct for protection against corona virus infection**

The rules of the authorities valid at the time are applied.

2. Advertising

Boats may be required to display advertising and bow numbers chosen and supplied by the organizing authority.

9. measurements:

- In addition to the WR 78.2 every boat must have the valid measurement certificate ready.
- All participants of surveying classes have to present the measurement certificate upon request. A Initial measurement cannot be carried out during the regatta.
- The race committee can carry out control measurements on boats by authorized persons and Check compliance with the rules and safety regulations.

10. evaluation

- The low-point system is used for the Formula 18
- If more than 6 boats of a class start, they get their own rating.
- The boats that do not start in their own class sail in an open class or in an open

If a boat is not entered in the table, the race committee will decide on the amount to be charged. The

Participants are required to assist the organizer in determining the settlement value at support.

- The allocation of clearing values or the grouping is done by the race management.

and cannot be the basis for a protest or a request for redress.

11. Boats places

- Boats must keep their allocated space on shore / in the water.

12. radio communication

- Except in case of emergency, a boat shall not transmit voice messages or data during the race, nor Receive voice messages or data that are not available to all boats.

13. disclaimer of liability

- The responsibility for the decision of a skipper to participate in a race or to continue, is solely up to him, he also takes responsibility for his team. The Boatman is responsible for the suitability and the correct nautical behaviour of his crew as well as for the suitability and the roadworthy condition of the registered boat. The organizer is entitled, in cases of force majeure or due to official orders or for safety reasons, to make changes in the execution of the event or to cancel the event.

At In these cases the organizer is not liable for damages to the participant.

A liability of the organizer, no matter for what legal reason, for property damage and financial losses of each nature and their consequences, which the participant has to bear during or in connection with the participation in the event through the behaviour of the organiser, his representatives, vicarious agents or representatives is excluded in the event of a breach of obligations which are not the main or essential contractual obligations. (cardinal obligations) are limited to damages caused intentionally or by gross negligence.

In case of violation of cardinal obligations, the liability of the organizer in cases of simple negligence is limited to foreseeable, typically occurring damages. As far as the liability for damages of the organizer is excluded or restricted, the participant is released from the personal Liability for damages also the employees - workers and employees - representatives

- vicarious agents, sponsors and persons who provide, drive or operate towing, securing or recovery vehicles, or assist in their use, as well as all other persons to whom the an order has been placed to carry out the event. The valid racing rules of World Sailing, the class rules as well as the regulations of the invitation to tender and sailing instructions must be observed and are expressly recognised."
- The law of the Federal Republic of Germany applies.

14. security:

- For emergencies: A mobile phone number, the sail number, the crew, and a contact person ashore must be specified or confirmed at the time of registration.

15. insurance

- All participating boats must have a valid liability insurance with a coverage of have at least €3 million per event or the equivalent thereof
- The proof of insurance must be presented at the regatta office without being asked.
