Submissions #3-6 and #10 are rule updates to align the IF18CA class rules with the updated Equipment Rules of Sailing (2021-2024 ERS) and Racing Rules of Sailing (2021-2024 RRS).

The purposes of following submissions are:

#1: to regulate the issuance of sail numbers

#2: to remove a class rule on buoyancy checks which by now has become obsolete

#7: to improve the identification and presentation of the F18 class

#8 and 9: to preserve safety following the introduction of the mainsail decksweeper.

Given the nature of these proposals, and in particular the limited impact on equipment, the proposal is for all these amendments to be implemented by 1 January 2021, coinciding with the introduction of the ERS and RRS updates.

12. Report on removal Class Rule C.3.3(c		AN

Current class rules C.3.3(b), (c) and (d) read:

C.3.3 WEIGHTS

- (b) **Crew** weighing less than 150 kg combined shall carry extra weight equal to half the difference between their actual weight and 150 kg.
- (c) C.3.3(b) does not apply if the crew uses both the Small Jib (maximum sail area 3.60 m2) and Small Gennaker (maximum sail area 19.00 m2), and provided these sails have been certified before 16 December 2018.
- (d) Crew extra weights shall be of metal and securely fastened on the port side, either to the outside of the front beam or to the strut and shall be removable for checking. Any weight of the **boat** in excess of 180 kg will count towards **crew** extra weights.

Class rule C.3.3(c) was approved at the World Council Annual Meeting of 15 December 2018 at which the class abandoned the use of the small rig with a grandfathering period of 2 years. This period has now lapsed and consequently this rule C.3.3(c) is to be removed.

After removal of C.3.3(c) the sentence "Any weight of the **boat** in excess of 180 kg will count towards **crew** extra weights." in C.3.3(d) can be moved to C.3.3(b).

13. ExCo report on regulation F18 jib	AN

A proposal for an in-principle decision was put forward to the 2019 Annual Meeting to investigate a change in the class rules that would allow the jib tack to be set below the bridle apex. The draft minutes of the meeting:

Feedback from the USA and some other NCAs suggests that the idea of disconnecting the positions of the jib tack and forestay bridle apex will only be widely supported for reducing stress in the hulls, by allowing the bridle apex to move upward, rather than in lowering of the jib position in search of further performance improvement of contemporary F18 designs.

The subject will be further investigated during 2020, with an intention to vote on any class rule amendment at the 2020 Annual Meeting, to be held in December 2020.

The meeting approves the proposal with 57% of votes casted in favour.

NOTE: any amendment of relevant class rules will require approval with 2/3rd majority of votes casted and would be effective no sooner than December 2021.

Further discussion with and among builders has resulted in a consensus view that there is no longer need for a change in the class rules. In contemporary F18 designs hull stress appears to be manageable and/or under control, and the general view is that the current class rules still work well.

ExCo concludes that there is no reason for a change in the class rules and that the discussion on this topic can be closed. We intend to inform sailors and other stakeholders of this decision after this Annual Meeting.
