

## **NOTICE OF RACE**

### **“5<sup>th</sup> MURTER CHALLENGE 2019 – TROPHY QUEST”**

#### **1. ORGANIZER**

Organizer of the catamaran regatta “5th Murter Challenge 2019” is DSR ADRIA SPORT

#### **2. PLACE**

Holiday Resort Jezera Village, Lovišća bay, Murter island.  
Sailing area is in the Murter & Kornati archipelago.

#### **3. DATE**

24<sup>th</sup> of May – 26<sup>th</sup> of May 2019.

#### **4. RULES**

The regatta will be governed by the ISAF rules 2017 - 2020 ie. the rules of racing (Racing Rules) and the sailing instructions.

#### **5. PARTICIPATION**

The regatta is open for first 20 claimed catamarans not bigger than 20 feet with a maximum of 2 crew members. All crew members should be verified in their national sailing federation. All crew members must have a valid health certificate from a sports doctor.

#### **6. REGISTRATION**

Registration will start on Monday, 25<sup>th</sup> of February at noon (12:00AM) via e-mail address DSR ADRIA SPORT: [info@dsradriasport.hr](mailto:info@dsradriasport.hr)

Application forms sent prior to the above will not be valid. In order to validate your registration - entry fee must be paid till 19.04.2019.

#### **7. FEES**

Entry fee is 80 EUR per competitor (person) and must be paid till 19.04.2019 the latest with a bank transfer:

Application forms without paid entry fee until 19.04.2019 will lose their slot in regatta and will not be able to compete. Right to contest will be given to the first (next) person on the waiting list with a week time (until 26.04.2019) to make a payment of an entry fee.

#### **8. CANCELLATION & REFUNDS**

Organizer is keeping the rights to cancel the event in a case of insufficient number of the boats registered. Regatta shall take place if one month prior to the event – on 24<sup>th</sup> of April – we have 50% of the quota registered (10 boats) with a paid entry fee in full. If we fail to have 10 boats registered until that date, regatta will be canceled and all entry fees will be refunded in full.

## **9. ADVERTISING**

Any advertisement that does not offend religious, racial or moral beliefs are allowed in accordance with the regulations of ISAF.

## **11. HANDICAP INDEX**

All sailors will be competing together. Class F18 will be scored separately. Upon completion of the registration at the first skippers meeting, RC will decide whether any other class should be scored separately.

Each skipper who participate in the class F18 must present a valid F18 class measurement.

Each skipper in the application must specify the class of racing, the manufacturer and type of catamaran, number of crew, and handicap.

Scoring is made by ISAF handicap system for small catamarans, published in March 2018 or later: <http://www.schrs.com/ratings.php>

Rankings are calculated according to the corrected time. If the boat is not in its original condition (hulls, sails, mast, rudder, etc.) or is self made must be accompanied by a certificate of conformity class.

## **12. SAILING INSTRUCTIONS**

Sailing instructions will be available at the first skippers meeting, on Thursday 23<sup>rd</sup> of May when preliminary decision about race courses will be presented.

## **13. COURSE**

Racing area will be marked on the map. Long distance navigations are scheduled, depending of the weather conditions. Also, possible are different courses and round robins.

## **14. SCORING**

After completion of 4 (four) races one will reject the worst result. Navigation and round robins scores the same. If the contestants share the same number of points, the number of better places will count, and if it will be tie, final race will count. There

is no maximum number of the daily races. The race is valid if 1 (one) navigation is regular, or 3 (three) round robins.

#### **15. ACCOMMODATION OF THE BOATS**

The area for the catamarans will be marked at the marina in the Lovišća bay (Holiday Resort Jezera Village), near the dinghy slip.

#### **16. ACCOMMODATION FOR THE COMPETITORS**

The organizer has provided accommodation at promotional prices for all participants in the Holiday Resort "Jezera Village".
